The acquisition also includes the traditional VULKAN brand, whose roots date back to 1898 and make it a pioneer in LED lighting for streets, parkings, pedestrian zones and public facilities.

With sales of almost 100 million euros forecast for the 2023 financial year, the RAGNI GROUP is expanding rapidly. This acquisition is in line with the French group's strategic vision of expanding its European footprint and, more broadly, consolidating its position as a leader in the street lighting and street furniture sector.
